## **Business Meeting April 12, 2018**

The Board of Supervisors of the Town of Isle Harbor convened at 8:04 pm on a cloudy 36° evening at it's townhall. Sup Haggberg, Sup Young, Clerk McGuire, and the town's contractor, RC Habeck were present.

The initial order of business was the clerk's reading of the minutes of the March 15, 2018 meeting. With no corrections, deletions, or additions, minutes were approved as read by motion, second, and unanimous passage.

The treasurer's report followed, with the following cash balances as of the date: Savings, \$25,086.82, and Checking \$104,723.02, for a total cash balance of \$129,809.84. Report was accepted by motion, second, and unanimous passage. Clerk also presented the current bank statement to the Chair for approval and initialing.

Motion by Sup Young, seconded by Sup Haggberg to have clerk present all outstanding orders for approval and discharge: such orders were: #4164, in the amount of \$245.00 to MN Benefit Assoc for group life policy, #4165, in the amount of \$314.23 for payroll, #4166 in the amount of \$375.17 for payroll, #4167 in the amount of \$254.34 for payroll, #4168 in the amount of \$240.11 for payroll, #4169 in the amount of \$3896.95 to City of Isle/Fire Dept for 1st installment of fire contract, #4170 in the amount of \$292.50 to Kowalczyk Gravel for snowplowing, #4171 in the amount of \$6885.00 to M/L County Auditor/Treasurer for 2017 assessment, #4172 in the amount of \$38.33 to M/L Messenger for legal notice, #4173 in the amount of \$50.00 to USPS for stamps, #4174 in the amount of \$1005.00 to RC Habeck for snowplowing, #4175 in the amount of \$300.00 to MN State Auditor for CTAS program. Total disbursements for April 2018 of \$13,896.63.
