## **Business Meeting, April 8, 2021**

The Board of Supervisors of the Town of Isle Harbor met at its townhall at 8:01 pm on this date, on a 42° rainy day evening. All members of the board were present, Sup Haggberg, Sup Olson, Sup Karels, and Clerk/Treasurer McGuire.

The floor was given to Mr. Richard Dutton who wanted to bring awareness to Isle Harbor of the organization BPOU (Basic Political Organization Unit). This organization meets the first Monday of the month at 5:00pm at The Timber Valley Grill in Milaca for those that are interested.

The clerk then read the minutes from the previous meeting of March 11, 2021. Such minutes were approved by motion, second, and unanimous passage. The treasurer's report followed showing the following balances: Savings balance of \$25,112.14 and Checking balance of \$103,467.75 for a total cash balance of \$128,579.89. The current bank statement along with the Cash Control Statement was presented to board for approval and signature.

Motion by Sup Olson and second by Sup Karels for clerk to present all outstanding orders against the town for approval prior to discharge. Such orders were so executed: #4515 in the amount of \$69.26 for payroll, #4516 in the amount of \$138.52 for payroll, #4517 in the amount of \$311.68 for payroll, #4518 in the amount of \$69.26 for payroll, #4519 in the amount of \$213.24 payable to Internal Revenue Service for Q1 941, #4520 in the amount of \$8.55 payable to Pamela McGuire for postage reimbursement, #4521 in the amount of \$5560.00 payable to Mille Lacs Cty Auditor-Treas. for 2020 assessment, and #4522 in the amount of \$80.00 payable to MN Benefit Association for adding new supervisor to group term life policy. Total disbursements for April 2021, \$6,450.51.

In road status report, Spring road inspection will need to be scheduled soon. Sup Haggberg will schedule with town's contractor RC Habeck.

In old business, reminder to the board that the Board of Appeal and Equalization is to be held at the town hall on April 21 at 1:00 pm. Sup Olson has obtained certification and all board members will be present.

In new business, the Spring Mille Lacs Cty Assoc. of Townships meeting has been cancelled, still due to COVID restrictions. The deadline for the MAT \$2000 scholarship for juniors is May 1, 2021.

In area of current correspondence, the following items were presented: Echos newsletter, LTAP newsletter, a thank you letter from Family Pathways for the towns pledge, and East Central Energy statement showing credit of \$244.41.
